Some felt there should be more emphasis on SLNC is to the development of the park and to the North Okanagan community. We need to submit a detailed future trail plan. SLNC is very much understated.

We should note that we are strong component of the BC Park and what SLNC gives back to the community. One good thing about the RFID is that it will show how many people are using the area. They need a better understanding of what we really do.

There seems to be something missing in the connection between what BC Parks sees and that most of the people wouldn't be there if there wasn't for SLNC. In addition, it is SLNC responds to all the emergencies. Why are winter sports not highlighted particularly when it is during winter that the business comes. Winter is disappearing in many places and with our elevation we have to accommodate winter sports and are the magnet for people to come.

There needs to be a call out on the number of Nordic skiers and the impact on park usage.

Need to review the numbers being used such as the number of trails and parking lot numbers.
