New Programs budget completed – thanks for everyone's help We are ending the season with strong revenue with decreased operational expenses

Season pass sales were up 210% over projections

Day pass sales were down 14% as forecasted

Lessons were up 9%

Rentals were down 10%

Merchandise sales up 4% over 3 year average

Septic tank & tiller were repaired

Shop heaters installed

First Aid incidents down 33% from last season

Programs have all ended except for Academy which ends in May Programs registration opens June 1st.

5. Finance See written report

Day passes very strong this year

Expenses \$200K lower than budgeted. Troy running skeleton staff, R&M very low this year. Should see a healthy year end. Nearing end of season and so all revenue has been collected.

Operating net profit \$211 at end of February.

6. Club Plan

Programs Plan presented to BOD

Budget was adjusted to 85% of initial budget through lowering projected number of participants and registration for Masters HP (which includes XC). The Plan as submitted is \$127K higher than actuals of Programs 2019-2020. FC has been quite active in this process and is comfortable with plan as submitted. Have not yet finalized day passes and duel passes with SS and so there could be some variation. It is a budget we can monitor. Program participation prices were adjusted so all programs could be more equal.

Discussion on whether the Masters HPers should be counted in the Masters XC capped numbers.

The Exec summary can be shared with the public

We should have a statement and the final exec summary to present to the public minus employee wages.

ACTION: Jeff to review final documents for appropriate financial information

7. Proposed Lodge project framework

Proposing project team be set up as a joint SLNC and BC Parks project. Lodge has been at least 8 years on the making. Will have project sponsors and project manager, as a paid position. Team to include 3 other positions: Communication/Fundraising/Grant

We are tasked to raise the money and yet it will belong to BC Parks. The BOD needs to have a realistic plan on what is possible.

Proposed Sovereign Star "Loppet". A marathon race in partnership with Silver Star March 2022.

Informal vision: To be a destination event from all over the world to promote outdoor activities, healthy lifestyles to showcase SLNC/Silver Star late season snow and to support the local Vernon Community.

Hope to build from 100/200 to over 1,000 participants in time and to add more events.

This will bring additional revenue at season end It would be a 50/50 split of revenue between SLNC and SS 2 day event Classic one day and skate the next 42K and 21K courses

Start at SLNC and finish on the downhill into the SS village
Has already had provisional support from Silver Star/Powdr and will
be presented to Silver Star Resort very soon.

General discussion was very positive. No ask of the BOD at this time, simply informative and a conditional "thumbs up" to keep moving ahead. More info will be conveyed to the BOD as it become available.
