Only 4 sick days for the entire staff this season – wearing masks is good

Machines are already set up for summer and fall operations as needed

All Programs positions are posted Main mechanic position will be posted shortly Full investigation done on tiller accident

5. Finance – see written report

2 surprise expenses this year with the septic and tiller

End of March with 2 month left in fiscal year, we are at 83% of last year which is higher than 75% COVID target.

Operations expenses \$180K less than last year

Expectation to end the season with an estimated surplus of \$100K.

Recommendation by the Finance Committee to buy 5 biathlon rifles. The FC supports this and feels it aligns well with overall support for Programs. Rec'd \$3K from Biathlon BC in a grant for the rifles. The purchase of 5 rifles will get us through the next season's expected growth. It is projected that Programs will be putting money away for future purchases. The new rifles will service 4 programs.

The rifles are stored in a 3 staged locked system, that is at a constant temperature. One of the Biathlon volunteers, coming from a military background who JD included maintenance and safety, has taken over this responsibility.

Motion: BOD approve \$8K from capital fund for purchase of 5 biathlon rifles. Approved

6. Committee Chair

It was agreed the COVID committee move to the Health and Safety committee

Action: BOD approves Chairs and Liaison as shown

7. Lodge project

BC parks has committed 1.5 million

Current cost ranges from 4 – 8.6 million

BC parks is looking at SL to raise 2.5 – 7.1 million

SL needs to start putting money away before we can look at grants and once BC Parks recognizes we are making an effort that will change their perspective. Should the BOD look at moving some money from the capital account to the lodge project as seed money?

Action: This will be discussed at the FC committee and brought back to the BOD in May.

Action: Project team will bring timeline and fundraising plan back to the BOD by June or July BOD meeting.

7b. S2SS

The S2SS event is rapidly gaining traction and support. People seems to be very positive about it. Many of the Chiefs are already moving forward to ensure a successful event.

Motion: The BOD officially support the S2SS event in principle subject to the review of the budget and coordinated with the Best of Snow. **Approved**
