W. Shannon gave the end of fiscal year report on behalf of the Finance Committee. The 2023-2024 fiscal year report included a focus on decreased revenue due mostly to decreased annual passes and day passes with increased expenses.

The Finance Committee proposed that major capital expenditures planned for 2024/25 be delayed, if possible, until December 2024. By that time the FC will know whether Season Pass Income and Programs revenue will have met budget expectations. Given this knowledge appropriate decisions about capital spending can be recommended at that time.

**Delaying Expenditures:** Wendy suggested delaying major capital expenditures, until a clearer financial picture emerges post-season pass and program revenue assessment in December.

**Lodge Committee Funding:** it was discussed reallocating funds within the Lodge Committee, suggesting using donation money instead of the previously allocated \$32,500 from the capital budget, pending further review.

- **Lodge Project Impact:** It was clarified that reallocating funds would not delay the Lodge project but would require revisiting the commitment of the club's contribution towards the project.

**Grooming Discussion:** The BOD discussed grooming and felt Operations could develop a more tactical grooming schedule.

**Motion:** SLNC will incorporate a tactical grooming plan to improve operational efficiency and to be decided by the GM and Grooming team.
